


ST COLUMBKILLE'S, RUTHERGLEN

FRESCO RESTORATION

The Perfect Gift - A Lasting Legacy





A beautiful way to remember our loved ones, both living and dead.

We have two beautiful side chapels here in St Columbkille's, each of which has a ceiling fresco.

The fresco in Our Lady's Chapel was painted by William Crosbie and depicts eight aspects of Our Lady's life, from the presentation in the temple to her Coronation in heaven.

The ceiling in the Sacred Heart Chapel by Walter Pritchard depicts the agony, crucifixion and resurrection of our Lord.

These two chapel ceilings have not been cleaned since they were painted in the early 1950's, and this combined with the usual airborne extraneous pollutants has led to candle soot deposits accumulating and being engrained into the surface of the murals.

The varnish has become dull and the colours are no longer as vibrant as they once were. In addition, external water ingress has lifted plaster and paint in many areas on both ceilings.

It is our hope to have these frescoes restored to their original state and in order to realise this project we would like to invite parishioners to make an offering, either in memory of a deceased family member/friend or to commemorate a living family member/friend. Your contribution will leave a lasting legacy for future generations. Every time we look up, we will remember to pray for our loved ones in a special way.

It is our sincere hope that this project will shortly be completed. We have sourced an art restorer who will seal the areas of loose lifting brittle paint before carrying out any other repairs, removing the dirt and retouching the lost artwork.
